### Minutes of the Meeting of the Parish Council held on 1 March 2017

**1. APOLOGIES FOR ABSENCE**

Apologies for absence were received from Councillors T Dunn, R Hughes and Mrs P Tolley.

**3. MINUTES OF THE EXTRAORDINARY MEETING HELD ON 14 DECEMBER 2016 & MEETING HELD ON 18 JANUARY 2017 & MATTERS ARISING:**

The Minutes of the Extraordinary Meeting held on 14 December 2016 and the meeting held on 18 January 2017 were approved and signed.

**4. REPORTS**

**4.1. Police Report:**

PCSO Bolton was unable to attend but his report had been circulated prior to the meeting. It was noted that in future the Parish Council would have to go online to find out information as it was unlikely there would be a report from the PCSO.

**4.2. Somerset County Council:**

County Councillor Davies reported that:

- A new free bus service was being provided by Hinkley Point between Minehead and Bridgwater.
- Drivers were being reminded to follow the temporary one-way system at Bridgwater whilst junction improvements and upgrades to traffic lights were being made at Bristol Road/The Drove and Wylde Road (the "Golden Triangle").
- Somerset will benefit from £24m of Government funding for five key projects to boost employment and economic growth. The projects were: Somerset Energy Innovation centre phase 3 in Bridgwater, Connecting Devon & Somerset Phase 2, iAero project in Yeovil, Toneway Corridor capacity improvements (Phase 1 Creech Castle) in Taunton and Huntspill Energy Park in Bridgwater.
- Somerset Libraries are supporting a national 'Be Online' campaign to get more people using the internet.

**4.3. District Council:**

District Councillor Dowding reported that:

- The formation of a new Council – consultation had now closed and meetings between West Somerset Council and Taunton Deane Borough Council were being held on a regular basis.
- New West Somerset Lottery was being launched in May 2017. In reply to questions raised at the last Parish Council meeting, the Clerk had circulated an email from Councillor Dowding.

- The Council Tax Precept will go up by the maximum amount allowed.
- West Somerset Council would balance the budget in 2017/18 but it was almost impossible to balance in 2018/19.
- Business rates for many were going to rise, Government policy on that has to be followed.
- At the last JAC meeting on the Quantocks, there were concerns about drones scaring people and animals.
- The Council were looking at reconfiguring the car park at Williton.
- Outline planning permission had been granted behind Lloyds Bank in Williton which would affect the bank.
