Hinkley SSG. Investment was being considered in and around the Bristol area for setting up a centre of excellence in the South West to move this and similar projects forward.

**20/84 Highway Matters**

20/84.1 Replacement of Weacombe Road sign – Highways had confirmed the road sign had been replaced in February 2020, but had since been damaged and removed. Highways confirmed they would order a replacement. It was suggested that the sign is moved away from the corner to try and stop the problem of cars crashing into it; the clerk would forward this request.

20/84.2 Painting of Finger Posts – Cllr Mote reported the posts at The Avenue and Staple Cross were in a fair condition, however, the Staple Cross post would benefit from a wash due to stickers that had been placed on it. Cllr Philipson had agreed to remove the ivy from the Weacombe Sign.

20/84.3 Request to reduce the speed limit to 20mph on The Avenue, Weacombe Road and Staple Lane - A breakdown of costs had been received and forwarded to members. It was agreed to ask Highways why this cost would lie with the Parish Council when parishioners pay for council tax, it was felt this should be provided by SCC.

20/84.4 Parishioners request for a 30mph speed limit along St Audries to Doniford Road due to poor visibility and unsafe conditions. Despite chasing several times, no response had been received from Highways. The clerk would continue to request an update.

**20/85 Grit Bins**

20/85.1 The Avenue – Cllr Hughes advised rather than being filled, the salt had been broken up and was useable.

20/85.2 Hill Lane – The order for a 100 litre bin had been placed; however, the company would not deliver to site. The clerk would be taking delivery and Cllr Philipson would arrange for it to be placed in situ.

**20/86 Footpaths**

Confirmation had been received that the footpath along the A39 from the Windmill to the old Rectory had been cleared.

**Somerset County Council:**

Cllr Davies highlighted the press releases that had been forwarded, which had included:

- Somerset Domestic Homicide Review Publication of Case 022.
- “Wish Jars” SCC had put together an action-packed list of things to do with your children from home - the aim, to keep children occupied and having fun during the holidays.
- Fast – Track Programme offers rewarding careers in Child and Family Social Work for talented graduates.
- £400k boost for Citizen Advice service.
- Volunteer from home and help to shape services across Somerset.
- Now is the time for one Somerset - one big opportunity to improve public services for all; The government had began a public consultation into changing the way local councils work in Somerset. It gives everyone the chance to have their say on setting up a unitary council approach. Scrapping all five councils in the county and creating a new and better way of working. Due to the public consultation the Government has now postponed the elections on 6<sup>th</sup> May for SCC until next year. (this means you will have to put up with me for at least another Year!!

There are two submission,

1; From the County Council, One Somerset to abolished all five councils and replace with a single unitary authority.

2; From the four district councils, ‘Stronger Somerset’. To replace all five and form two unitary authorities. Which would see Somerset West & Taunton join with Sedgemoor and South Somerset join with Mendip.
